# RATE SHEET FOR MEASURED BUSINESS LINES

Service	Monthly	Installation
1 Measured Business Line	\$13.25 (does not include a \$1.25 Non Pub charge, \$4.38 FCC surcharge and \$0.65 USF) Plus usage	\$67.21 per line

This service is sometimes called 1MB Service or POTS (Plain Old Telephone Service). It allows both incoming and outgoing calls. You can get 900/976 Blocking at no additional charge when the lines are installed. There is a \$14.25 per line charge to add or remove 900/976 Blocking after the line has been installed. There are many features available with this type of service. We have only listed the features most commonly used for Special Events on this form.

**There is a minimum billing period of one month on all services.**

The intallation charge listed above will install the line at the MPOE (Minimum Point of Entry). To install the jacks and inside wiring, you may choose between:

- Doing the wiring yourself
- Hiring a vendor to do the wiring
- Hiring AT&T to do the wiring

Please be sure to check with the Facility Manager who is handling the event. Some facilities require that you hire their vendor to do the wiring. In that case, AT&T is only allowed to take the lines to the MPOE.

If you decide to hire AT&T to do the wiring, the charges are listed below. These charges are for the RJ11C jacks, as that is what is most commonly ordered for Conventions and Special Events. If you require a different type of jack, or if your installation is in an unusual location like a park, additional engineering and/or cabling charges could apply. Please call us for an individual quote if that is the case.

Jacks & Wiring Charges	Monthly	Installation
RJ11C Modular Jack	None	\$6.00 per jack
Labor First Jack	None	\$135.00
Jacks 2 through 5	None	\$70.00 per jack
Jacks 6 and beyond	None	\$55.00 per jack

These rates are based on work done during our regular business hours. An additional charge of \$300.00 per technician per day is charged if you request the work be done on an overtime basis.

If the owner of the facility requires that AT&T return after the event and remove the wiring, a removal fee will apply. This is a time sensitive charge at the rate of \$85.00 for the first fifteen minutes and \$30.00 for each additional fifteen minutes. A minimum of \$85.00 would apply.
